





### Formulation Guidance

- Keep pH above 3.0 to avoid hydrolysis
- Can add to 2-in-1s or conditioning cleansers after the anionic surfactants – incorporate pearl or opacifying agent
- Avoid heating formula above 75°C (color bodies may form)






